**MINUTE ENTRY for Status Conference held before Judge Brian M. Cogan by telephone on 2/27/2013. Counsel for plaintiffs, defendant, and objectors Cermak and Frank present. The Court granted plaintiffs' letter motion [215] for extension of time to file response/reply and request for leave to file motion to amend plaintiff's plan of distribution by 3/1/2013. The parties agreed to adjourn the final fairness hearing scheduled for 3/13/2013 to 4/5/2013, however, following the status conference, the Court recognized that 4/8 is a viable option after all. Therefore, the new adjourned date for the fairness hearing shall be 4/8/2013 at 10 a.m. in Courtroom 8D South. Plaintiffs must inform the objectors by 3/1/2013: (1) that the final fairness hearing has been adjourned to 4/8/2013 at 10 a.m., (2) that any comments or objections to plaintiffs' amended plan of distribution must be received by the Clerk of the Court no later than 3/15/2013, with a copy to counsel for plaintiffs and defendant also to be received no later than 3/15/2013, (3) and that if the objectors wish to be heard at the adjourned final fairness hearing, they must indicate in their written objection their intention to appear at the hearing. Plaintiffs must file proof of service of such information upon objectors with the Court. Finally, plaintiffs shall have until 3/22/2013 to respond to any timely-received comments or objections to their amended plan of distribution. See transcript for details.
